
Methodology

- This online survey was conducted among 1,101 current members of the INNOVATIVE's Canada 20/20 panel from **5pm EDT**, **July 24**th to **10am EDT**, **July 28**th, **2009**.
- The Canada 20/20 Panel is recruited from a wide variety of sources to be representative of the known distribution of Canadians by age, gender, region and language.
- Each survey is administered to a series of randomly selected sub samples of the panel and weighted
 according to Census data to ensure that the sample is representative of the age, gender, region and
 language breakdown of the Canadian population to provide results that are intended to approximate a
 probability sample.
- Each panellist is provided with a unique URL in their invitation so that only invited panel members are able to complete any specific survey. Each URL can only be used to complete one survey.
- The weighted total sample included **1,038** responses eligible for inclusion in our analysis as regions with proportionately larger samples were weighted down.
- An unweighted probability sample of 1,101 would have an estimated margin of error of ±3.0 percentage points, 19 times out of 20.
- The margin of error will be larger within each sub-grouping of the sample.

Key Findings

Canadian attitudes towards Nortel's foreign asset sales



Overview

- The issue of the Nortel asset sales right now is only a mild problem for the government, but that is because people are not very familiar with the leading edge technology.
- As voters learn more about the value of Nortel's existing assets, the appetite for intervention grows and the government becomes more at risk.
 - Once people become aware of the leading edge technology angles, Nortel becomes more important as a company in the minds of Canadians. After priming respondents with information on Nortel's wireless technology, 44% say they see the company as an important national asset vs. only 27% who felt this way before this information was presented.
 - After presented with information on the value of Nortel's wireless technology, over 4-in-10 Canadians (44%) believe the federal government should intervene in Nortel's bankruptcy proceeding on behalf of RIM, while 26% think it would be a mistake and 30% of Canadian don't know what the federal government should do.
 - A majority of Liberals (56%) and NDP supporters (56%) think the government should intervene.
 - At the regional level, a majority of Prairie (64%) and Ontario (52%) residents believe the government should intervene.
 - If Nortel's technology ends up being controlled by a foreign company, nearly 1-in-5 Canadians (18%) say they're less likely to vote for the Conservatives in the next election.
 - With that said, most of those who say they would be less likely to vote for a Conservative government under this scenario would vote for another party other than the Conservatives regardless of the ownership outcome of Nortel's technology.
 - However, 19% of Ontarians say they'd be less likely to vote for the Conservatives in the next election if Nortel's technology ends up being controlled by foreigners.
 - As well, 16% of Undecided voters say they'd be less likely to vote Conservative if this situation occurs.
- Nearly half of Canadians (45%) are opposed to EDC funding support to foreign companies interested in purchasing Nortel's assets. Just over 1-in-10 Canadians (12%) support EDC funding to foreign firms, 13% neither support nor oppose, while 30% don't know enough to say.











How closely have you been following the news stories regarding the financial troubles of Nortel Networks?




Government approval by vote intention




Perspectives of Nortel

Initially, more see Nortel as JUST ANOTHER COMPANY as see Nortel as an IMPORTANT NATIONAL ASSET




Awareness of RIM's interest in Nortel assets

Over half the panelists (58%) have heard something about RIM's interest in buying Nortel's wireless division.






Plurality oppose Government's decision <u>not</u> to intervene



Right now the bankruptcy courts are running an auction to sell Nortel's assets. Only three bidders have made it through the official process to be recognized bidders, Nokia Siemens from Finland and Germany, Ericsson from Sweden and a private investment bank from New York.

A Canadian company, RIM, has argued that the auction rules were unfair and requested the federal government intervene to allow it to participate in auction. The government has chosen not to intervene.




Support | opposition to federal government intervention by vote intention




Significant opposition to EDC funding for a foreign firm



Currently the Nokia Siemens \$650 million bid for some of Nortel's assets has \$300 million in funding through a loan from the federal government owned Export Development Corporation (EDC). The EDC says it will offer funding to any Canadian or foreign company on commercial terms if there is a benefit to Canada.




Low familiarity with Nortel's leading technology

Less than half of Canadians (48%) say they are very familiar or somewhat familiar with Nortel's leading edge wireless technology.






Importance of Nortel grows after learning about technology


From your perspective, do you see Nortel as an important national asset for Canada, do you see Nortel as just another company, or do you not know enough to say one way or the other?




World class Canadian wireless company seen as major economic benefit



Summary



Summary

- The recent stories about the financially troubled Nortel Networks have a relatively low profile among Canadians with only 6% saying they have been following related stories about the company very closely and 33% saying somewhat closely.
- Among those who have been following the story to varying degrees, 13% approve of the way the federal government has managed the "Nortel issue" while 33% say they disapprove of the way the federal government has handled the issue.
 - Among voters, the strongest approval rating of the federal government's management of this situation comes from Conservative supporters (22%), followed by Bloc supporters (16%).
 - The strongest disapproval of how the federal government is managing the Nortel issue comes from Liberal supporters (42%) and NDP supporters (36%).
 - From a regional perspective, Ontario (43%) and the Prairies (35%) are most likely to say they disapprove of the how the federal government is managing the Nortel issue.
 - Albertans (25%) are most likely to approve of the federal governments management on this issue.
- Nortel as a company is not particularly special in the minds of Canadians (34% say it's just another company vs. 27% saying it's an important national asset). However, once people become aware of the leading edge technology angles the company becomes more important. After priming respondents with information on Nortel's wireless technology, only 23% of Canadians believe Nortel is just another company vs. 44% who see the company as an important national asset.
- Almost 6-in-10 Canadians (58%) recall having heard something about Research In Motion's interest in buying Nortel's wireless division.
- In terms of public opinion over the government's decision not to intervene in Nortel's bankruptcy proceeding on behalf of RIM, 22% of Canadians support the federal government's decision not to intervene; 37% oppose the government's decision; while 30% of Canadians don't know enough to say.
 - Half of all Liberal supporters (50%) oppose the government's decision, followed by NDP supporters (41%), Green supporters (31%) and undecided voters (30%).
 - 1-in-3 Conservative supporters (34%) say they support the government's decision, followed by Bloc supporters (30%).



Summary [2]

- Prairie residents (54%) and Ontarians (48%) are most likely to <u>oppose</u> the government's decision not to intervene in the Nortel bankruptcy proceedings on behalf of RIM.
- Nearly half of Canadians (45%) are opposed to the EDC funding a foreign company's purchase of Nortel's assets.
- Over half of Canadians (54%) see the creation of a dominant international Canadian wireless company to have a MAJOR benefit to the economy.
 - A majority of Liberals (63%), Conservatives (59%), Greens (56%) and NDPs (51%) believe the combination of RIM's success with the Blackberry and Nortel's wireless technology would have a MAJOR benefit to the Canadian economy.
 - A majority of respondents from all regions except Alberta and Quebec also believe this combination would have a MAJOR benefit to the Canadian economy.
- A plurality of Canadians (44%) believe the federal government should intervene in Nortel's bankruptcy proceeding on behalf of RIM, while 26% think it would be a mistake and 30% of Canadian don't know what the federal government should do.
 - A majority of Liberals (56%) and NDP supporter (56%) think the government should intervene.
 - At the regional level, a majority of Prairie (64%) and Ontario (52%) residents believe the government should intervene.
