BC Strikes – Tracking poll

### Methodology

- Each wave of tracking was conducted via an online survey among current members of the INNOVATIVE's Canada 20/20 panel in British Columbia only.
- The following table provides dates, sample sizes and margins of error for all waves of tracking:

July 25	August 1	N=233	±6.4%	
August 2	August 8	N=235	±6.4%	
August 8	August 15	N=225	±6.5%	
August 15	August 22	N=232	±6.4%	
August 23	August 29	N=299	±5.7%	
August 30	September 2	N=473	±4.5%	

- For this week, field was conducted between August 30<sup>th</sup> and September 2<sup>nd</sup> and 473 British Columbians completed the survey, with a margin-of-error of plus or minus 4.5%.
- The margin of error will be larger within each sub-grouping of the sample.




### Both parties viewed as being unreasonable, gap narrows this week



Which negotiating party do you feel is generally most to blame for the labour dispute? Do you think it is mostly the fault of...?




# City has slight edge over union in support with more than one third on the fence



Allowing the city to consider both external and internal candidates for certain jobs instead of being required to promote people from within



How much have you been personally affected by the Vancouver municipal strike so far this summer? Would you say ...?




### Vancouverites most likely to feel impact


How much have you been personally affected by the Vancouver municipal strike so far this summer? Would you say ...?

### Most anticipate no impact




### Vancouverites most likely to anticipate impact

### Summary 1

The public views both sides in the City strike in a similar negative light:

- Both sides in the Vancouver labour dispute have been seen as more unreasonable than reasonable for six consecutive weeks. The union is seen as slightly more unreasonable than the City.
- Slightly more blame the City for the dispute, and one-quarter of respondents (26%) blame both parties equally.
- Slightly more support the City (34%) over the union (30%), but 28% support neither side.

At the political level, the Mayor suffers from spotlight:

- There is 3:1 disapproval of both the Mayor and the opposition councilors.
- However, since there was much lower awareness of the opposition, the Mayor is at a disadvantage.





### Summary 2

Public supports arguments on both sides of the dispute

- Whistleblower protection is strongly supported (68%) along with giving the City the ability to consider external and internal candidates for certain jobs (68%).
- There is a clear division on the issue of contracting out, with 38% in support, and 42% opposed, including 24% who strongly oppose.

Personal impacts not strongly felt

• Less than half of Vancouverites say they have been personally impacted by the strike, and there is no increase in concern over personal impacts when the public is asked to look ahead.
