
### Methodology

- These are the findings of an Innovative Research Group (INNOVATIVE) poll conducted from May 7th to May 14th, 2018.
- This online survey of 2,327 Canadian adults was conducted on INNOVATIVE's Canada 20/20 national panel.
- The Canada 20/20 Panel is recruited from a wide variety of sources to reflect the age, gender, region and language characteristics of the country as a whole. Each survey is administered to a series of randomly selected samples from the panel and weighted to n=1,500 to ensure that the overall sample's composition reflects that of the actual Canadian population according to Census data to provide results that are intended to approximate a probability sample.
- INNOVATIVE provides each panellist with a unique URL via an email invitation so that only invited panel members are able to complete the survey and panel members can only complete a particular survey once.
- Since the online survey was not a random probability based sample, a margin of error can not be calculated. The Marketing Research and Intelligence Association prohibits statements about margins of sampling error or population estimates with regard to most online panels.

**Note**: Graphs and tables may not always total 100% due to rounding values rather than any error in data. Sums are added before rounding numbers.


# **Federal Party ID:** 3-in-10 in Rest of Canada identify as Conservative (29%) and Liberal (28%) with 23% unaligned


# Support for Various Oil & Gas Projects



### **Support Segmentation:** Half (56%) are in the Battleground Groups, with 29% in Soft Support and 21% Disengaged


Based on the four questions on general support for oil projects, we group respondents into six groups.

- **Strong Support** includes respondents who say support more often than oppose, and say *strongly support* three or four times.
- **Soft Support** includes those who say support more often than oppose, and say *strongly support to* no more than two out of the four projects asked.
- **Disengaged** includes those who say *don't know* or *neither support nor oppose* at least three times.
- **Conflicted** includes those who are equally likely to say either support or oppose. This group also includes those who say support once more than oppose (or vice versa) and have given a strong opinion only once.
- **Soft Opposition** includes those who say oppose more often than support, and say *strongly oppose to* no more than two out of the four projects asked.
- Strong Opposition includes those who say oppose more often than support, and say strongly oppose three or four times.

Segmentation BY Region and Federal Party ID






# Awareness: 6-in-10 (58%) have followed the news at least <sup>11</sup> somewhat closely; highest among strong supporters (91%)




### **Approval Support:** Half (50%) support federal government's<sup>12</sup> expansion approval; highest in Alberta (82%)

### **Fed Gov't Management Support:** Opposition (36%) higher <sup>13</sup> and more intense than support (24%)




### **BC and Alberta Dispute**



### **BC/AB Dispute:** Less than half view either province as reasonable, but AB seen as more reasonable than BC


Since the federal government approved the Trans Mountain pipeline expansion, there has been a dispute between the BC government and the Alberta government.


### **Alberta Government:** Most Albertans (74%) say their gov't has been reasonable, but only 38% across Canada






### **BC Government:** Only a third (34%) of residents feel the BC <sup>17</sup> government has been reasonable, much lower outside BC








# **Most Reasonable:** Those following most closely are more than 2x as likely to deem AB gov't most reasonable over BC




