Methodology



These are the results of the June 2019 Canada This Month survey conducted between June 28th and July 8th, 2019.

This online survey of 2,515 adult Canadians was conducted using INNOVATIVE's Canada 20/20 national research panel with additional respondents from Lucid, a leading provider of online sample. The results are weighted to n=1,200 based on Census data from Statistics Canada.

Respondents from the Canada 20/20 Panel and the Lucid constituent panels are recruited from a wide variety of sources to reflect the age, gender, region, and language characteristics of the country as a whole. Each survey is administered to a series of randomly selected samples from the panel and weighted to ensure that the overall sample's composition reflects that of the actual Canadian population according to Census data to provide results that are intended to approximate a probability sample.

INNOVATIVE provides each panellist with a unique URL via an email invitation so that only invited panel members are able to complete the survey, and panel members can only complete a particular survey once. Sub-regional quotas are set within regions to ensure there is a representative sample of respondents from across the entire region.

Confidence: This is a representative sample. However, since the online survey was not a random probability based sample, a margin of error cannot be calculated. Statements about margins of sampling error or population estimates do not apply to most online panels.

Weighting: Results for Canada are weighted by age, gender, and region to ensure that the overall sample's composition reflects that of the actual population according to Census data; in order to provide results that are intended to approximate a probability. Weighted and unweighted frequencies are reported in the table.




Federal Party ID: Liberals maintain their lead in partisanship as CPC drop directionally to 23%



Thinking about politics in Canada, generally speaking, do you think of yourself as a...





Support for Resource Development Infrastructure: Support is higher for natural gas pipelines than any oil-related infrastructure



Based on respondents support for both natural gas and oil pipelines, they were grouped into similar segments for analysis.






Pipeline Support: Majority of Conservatives and Liberals are supporters of pipeline projects

Pipeline Support BY Party ID and Region






Approval: Net support for the pipeline approval is up since September 2018 from +22% to +31%



Attention to Review: Attention to the review has slipped slightly since September 2018, but 46% still say they are following closely






Support for Renewed Approval: A majority (52%) support the renewed approval after additional consultations



The federal government has now completed an additional consultation with First Nations. Several weeks ago, the federal government announced that process is completed and, after an additional review by Cabinet, renewed its approval to build the expansion with eight additional conditions to address First Nations concerns.





