#### **Carbon Tax Changes**

INNOVATIVE has been tracking attitudes towards the carbon tax since the Trudeau government introduced it in 2016.

Today, INNOVATIVE is releasing the results from our April 2021 *Canada This Month* survey. This online survey was in field from April 1<sup>st</sup> to April 13<sup>th</sup> with a weighted sample size of 1,500 Canadian residents. Detailed methodology is provided in the appendix.

This report covers Canadians' awareness of and support for the new carbon tax increase announced by the Trudeau government in late 2020 as well as the Supreme Court of Canada ruling to uphold the federal carbon tax.

### **General Support for Carbon Tax:** Nearly half (45%) support a carbon tax, with support highest among Liberal, NDP, and Green partisans



### **Tracking General Support for Carbon Tax:** Net support for the carbon tax has increased four points since December 2020


Do you support or oppose the federal government implementing the following policy?






# **Following Carbon Tax Announcements:** The share following closely continues to be lower than before the updated policy was announced

How closely have you been following the news about this announcement?



### **Policy Support:** A plurality (44%) support the policy, but 3-in-10 (28%) oppose it with 18% saying 'strongly oppose'
















## **Following Supreme Court Ruling:** Those from Alberta and the Prairies and CPC partisans are the most likely to be following the ruling closely


#### **Following Supreme Court Ruling:** A majority (56%) of populist conservatives report following the ruling closely



Do you support or oppose the decision by the Supreme Court of Canada to uphold the federal carbon tax? [asked of all respondents; n=1,500]





Do you support or oppose the decision by the Supreme Court of Canada to uphold the federal carbon tax? BY Region and party ID [asked of all respondents; n=1,500]





#### O you support or oppose the decision by the Supreme Court of Canada to uphold the federal carbon tax? BY Political value clusters and the economic gap segmentation



#### Methodology

#### **Survey Methodology**

#### These are the results of an online survey conducted between April 1<sup>st</sup>, 2021 and April 13<sup>th</sup>, 2021.

**Method:** This online survey was conducted using INNOVATIVE's Canada 20/20 national research panel with additional respondents from Dynata, a leading provider of online samples. Each survey is administered to a series of randomly selected samples from the panel and weighted to ensure that the overall sample's composition reflects that of the actual Canadian population according to Census data to provide results that are intended to approximate a probability sample.

**Sample Size:** n=2,390 Canadian citizens, 18 years or older. The results are nationally weighted to n=1,500 based on Census data from Statistics Canada.

Field Dates: April 1st, 2021 to April 13th, 2021

**Weighting:** Results for Canada are weighted by age, gender, and region to ensure that the overall sample's composition reflects that of the actual population according to Census data; in order to provide results that are intended to approximate a probability sample. Weighted and unweighted frequencies are reported in the table.

**Margin of Error:** This is a representative sample. However, since the online survey was not a random probability based sample, a margin of error cannot be calculated. Statements about margins of sampling error or population estimates do not apply to most online panels.

**Note**: Graphs may not always total 100% due to rounding values rather than any error in data. Sums are added before rounding numbers.
