Building from the findings of the report published on Friday, March 21<sup>st</sup>, 2025 (<u>https://innovativeresearch.ca/liberals-take-lead-on-election-eve/</u>), this report further expands on the campaigns of the major parties in this federal election:

- Awareness of the four major parties,
- What voters are reading, seeing or hearing about each party,
- And the impact of those messages.



## Summary

1	<b>Carney and the Liberals are gaining on the most common recalled messages.</b> Carney and the Liberals have the attention of 63% of the electorate, and they are using it to good effect. Carney's most mentioned news items include his meeting with European leaders (+36), news about him becoming Prime Minister (+22), eliminating the carbon tax (+26), and his stance on Trump and tariffs (+49).
2	<b>Poilievre and the CPC are losing more than they are gaining.</b> Just under half (45%) have heard anything about Poilievre and the Conservatives. He is losing ground on his criticism of the Liberal Party and Carney (-34), abolishing the carbon tax (-9) and being compared to Trump has the most negative net impact of -78. However, he does get a strong positive score (+26) on dealing the US and Trump tariffs.






The Bloc is struggling to get attention, but doing well with those they reach. Only 15% of Quebecers heard anything about the Bloc the week before the election call, but they receive a net impact score of +17, virtually tied with Carney and the Liberals. The top mentions contributing to that score include comments on the Liberals and Carney, giving priority to Quebec, and general positive comments.


# **Campaign Attention And RSH Impact:**



### **Carney's meeting with European leaders is most mentioned and viewed favourably**

# **RSH Liberals:**

### Top RSH topics include meeting EU leaders, becoming PM, and eliminating carbon tax

And what have you read, seen or heard about Mark Carney and the Liberals in the last few days? [OPEN END]

[asked only of those who RSH about Mark Carney and the PCs; n=626]

#### Meeting with European leaders:

- "Carney is making contact with leaders in the EU to discuss tariff implications and possible reactions to plans of the Trump Government in the USA. He is holding off on any discussions with the American President at this time."
- *"First international visits were to France and UK to discuss more trade with Europe and strengthen our alliance with European powers and we a reliable ally. His visit to Nunavut and the need to protect our sovereignty in the Arctic and a new early warning system."*
- *"He met with Macron and Starmer. He has no immediate plans to meet with Donald."*

#### Carney became PM/Liberal leader:

- "He has stepped into the prime minister job with both feet....intelligent, caring and a doer...he will get us through the new world order and make Canada stronger and more prosperous."
- *"I read that he was chosen to lead the Liberals and that he's making changes to the party and plans for the future, especially how to deal with Trump."*
- "The liberal choose mark carney as a leader of their party and prime Minister of Canada as well. Suppose to next federal election will be fight in the leadership of Mark carney."

#### Eliminating carbon tax:

- "Carney and Liberals drop the carbon tax on individuals, but support continuing the carbon tax on industries including future increases as already proposed."
- *"The most notable thing I've heard about Mark Carney in the past few days is the changes he is making to the carbon tax."*
- "I saw he said he would eliminate the consumer carbon tax "immediately". Of course, he hasn't done so."

# **Impact of RSH for PCs:**

# **RSH PCs:**

### Top mention are LPC/MC criticism, carbon tax abolishment, and general negative comments

#### **Criticism of Liberal Party and Mark Carney:**

- *"His smear campaigns against the new PM. Pierre has a nefarious background himself, he agrees with Trump on a lot of issues, no trust for this man at all."*
- *"I watched a video of him explaining that Mark Carney isn't actually axing the carbon tax he is just hiding it and that it could be brought back at any time."*
- "Just his usual blaming of everything on the Liberals."

Abolish carbon tax:

• "Speaking about carbon tax, and what his party would put forward if elected compared to what current liberal have completed."

"Recently did a presentation vowing to eliminate all carbon related


"Mostly him ranting about the carbon tax."

#### Negative - general:

- *"He's dreadful as he has always been. He's continuing his rhetoric about how he is the best for the country."*
- "Regarding this party, I've read that it's time to change these customs and beliefs. The world has evolved and changed, and this party no longer fits with current beliefs and thinking."
- "I do not like the fact that he always acts like an attack dog."

# Impact of RSH for New Democrats:

### Top mention for Singh are media and ads; support for Liberals and Carney has the most negative effect

## **RSH New Democrats:**

### Top mention for Singh are media/ads, his support for the Liberals/Carney, and the loss of support from his base

Have you read, seen or heard anything about Jagmeet Singh and the NDP in the last few days? [OPEN END]

[asked only of those who RSH about Jagmeet Singh and the NDP; n=169]

#### Media and ads:

- "I have heard that Jagmeet Singh is holding a media event about the election."
- "I've just seen ads on TV about him."
- "Same old ads about Singh that the Conservatives have been showing for months now."

#### Singh supports the Liberals and Carney:

- *"He has said Canadians need to stand together. He congratulates Mark Carney on his election."*
- *"As usual he will prop up the Liberals. They don't call him sellout Singh for nothing. He has helped the Liberals destroy Canada."*
- "How he may back the liberal government in parliament instead of forcing an election."

#### Singh losing support:

- "Support for the party is tanking. In my opinion, he is grasping for something to reignite support for his party. Not going to work, I'm afraid."
- *"That NDP support in the polls has dropped considerably with some supporters moving to the Liberals to prevent a Conservative party majority."*
- *"Their support is sliding away."*



# **Survey Methodology**



# These are the results of an online survey conducted between March 19<sup>th</sup> and March 21<sup>st</sup>, 2025.

**Method:** This online survey was conducted and sponsored by Innovative Research Group Inc. using INNOVATIVE's Canada 20/20 national research panel with additional respondents from Lucid, a leading provider of online sample. Each survey is administered to a series of randomly selected samples from the panel and weighted to ensure that the overall sample's composition reflects that of the actual Canadian population according to Census data to provide results that are intended to approximate a probability sample.

**Sample Size:** n=1,548 Canadian citizens, 18 years or older. The results are nationally weighted to n=1,000 based on Census data from Statistics Canada.

Field Dates: March 19<sup>th</sup> and March 21<sup>st</sup>, 2025.

**Weighting:** Results for Canada are weighted by age, gender, region, education, and self-reported federal past vote to ensure that the overall sample's composition reflects that of the actual population according to Census data, in order to provide results that are intended to approximate a probability sample. Weighted and unweighted frequencies are reported in the table.

**Margin of Error:** This is a representative sample. However, since the online survey was not a random probability-based sample, a margin of error cannot be calculated. Statements about margins of sampling error or population estimates do not apply to most online panels.

**Note**: Graphs may not always total 100% due to rounding values rather than any error in data. Sums are added before rounding numbers.
