#### Study Overview

Building on findings from previous waves, this report tracks July data about:



- Reactions to Trump
- Response to USA
- Digital Service Tax



#### **Key Findings**

The federal government's approval of handling Trump related issues further drops 5 points in July to 39%, with a 11-point drop in net approval since the previous month. Among 23% who disapprove, the common perception is that Carney and the federal government are weak or inexperienced (19%) and should take a stronger stance, or that they are not doing enough (19%).

PM's net favourability (now at 12%) also further drops and is 19 points lower than in June. Even though the interest in the Canada-U.S. relationship remains high, with three in four Canadians closely following, the number of Canadians who have read, seen, or heard (RSH) something about PM further drops to the lowest since he was elected (42%). The strongest cited driver of low favourability is caving to Trump on the digital tax (7% mentioned it).

48% of Canadians think that taxing US tech giants is a good idea, 21% are undecided, and 32% think it is a bad idea. Carney's decision to suspend it divided opinions; 26% say he was wrong to suspend it, while 30% say he was right. Views on the suspension also split partisan lines, with 40% of Liberals, 30% of Conservatives, and 23% of NDP supporters in agreement.


The net effect of dealing with digital tax on PM's favourability is a negative score, such that 27% now view Carney less favourably and 24% more favourably based on events around digital tax. The drop in favourability is most notable among older cohorts, in Alberta, and across all political affiliations except Liberal.

One-third of Canadians identify as "Strugglers" in the economic gap segmentation, outnumbering "Achievers" and "Alienated" (both at 23%). With 62% agreeing it's harder to get by each year, for Canadians who remain highly engaged in the news cycle and frequently recall Trump, tariffs, and trade, the economic anxiety could magnify the perceived political indecisiveness as damaging to the PM.




### **Economic Gap Segmentation:** 1-in-3 are strugglers, followed by Achievers and Alienated at 23%




#### Party ID: Quebec

[Respondents in the rest of Canada; n=1,540]






### **Tracking Party Identification (Quebec):** Liberals have dropped 5 points from the previous month but still maintain the lead at 32%




Thinking about politics in Canada, generally speaking, do you usually think of yourself as a... [asked of those in Quebec; n=460]

Thinking about politics in Canada, generally speaking, do you usually think of yourself as a... [asked of those outside Quebec; n=768]




# **Value Clusters:** Business Liberals (23%) are the highest value cluster, followed by Pay-as-you-go at 19%

### **Core Political Values:** Nearly 2-in-3 believe the main role of the government is to create equal opportunity




When governments make major decisions concerning spending on programs and services, do you think they should be basing their decisions mainly on...?








Which of the following statements comes closest to your view?






### **Engagement with U.S.-Canada Relationship:** Attention to U.S.-Canadian relations remains stable from April 2025






# Attitude Towards President Trump: Excitement towards Donald Trump remains relatively steady since April and low, now at 12%



Does Donald J. Trump's election as the US President leave you feeling excited or afraid? [asked of all respondents; n=2,000]






### **Federal Government's Approval:** Approval further drops 5% since the end of June, now at 39% with 23% unsure



Now thinking about the federal government, do you approve or disapprove of the way the Federal government is responding to issues resulting from Donald Trump's presidency?



# **Provincial Government Approval:** BC and ON have the highest net approval scores, statistically unchanged since June




#### BC Government Response to Trump's Presidency - Approve:




















# **Federal Government Approval:** 12-point drop in net approval of the federal government's response to Trump related issues


#### Federal Government Response to Trump's Presidency - Approve:


#### Federal Government Response to Trump's Presidency - Disapprove:



Have you read, seen or heard anything about Canada's Prime Minister and the Federal government in the last few days?






#### Read, Seen, Heard Tracking: Further drop in following news about the 32 **Prime Minister**



Have you read, seen or heard anything about Canada's Prime Minister and the Federal government in the last few days? [asked of all respondents; n=2000]










### **PM's Read, Seen, Heard, Impact Tracking:** Net favourability is 19 points lower than in June and at 12% is close to February levels




### **Digital Service Tax Awareness:** 55% of Canadians are aware of it; men (64%), liberals (66%), and older (65%) are more likely to follow it







### **Digital Service Tax:** 48% Canadians think digital tax is a good idea, and 32% that it is a bad idea; Conservatives are least likely to support it





### Carney's Repeal: 40% Liberals think Carney was right to suspend it, vs 23% NDPs or 30% Conservatives

Do you think Mark Carney was right or wrong to repeal the digital service tax that applied to US tech companies after the US threat to terminate all trade negotiations with Canada?








### Mark Carney Favourability: 37% Canadians did not change opinion of Carney because of digital tax; 24% are now more and 27% less favourable

### Methodology

#### **Survey Methodology - National**



These are the results of an online survey conducted between July 04 and July 28, 2025.

**Method:** This online survey was conducted and sponsored by Innovative Research Group Inc. using INNOVATIVE's Canada 20/20 national research panel with additional respondents from Lucid, a leading provider of online sample. Each survey is administered to a series of randomly selected samples from the panel and weighted to ensure that the overall sample's composition reflects that of the actual Canadian population according to Census data.

**Sample Size:** n=3,732 Canadian citizens, 18 years or older. The results are nationally weighted to n=2,000 based on Census data from Statistics Canada.

Field Dates: July 04 and July 28, 2025.

**Weighting:** Results for Canada are weighted by age, gender, region, education, and self-reported federal past vote to ensure that the overall sample's composition reflects that of the actual population according to Census data. Weighted and unweighted frequencies are reported in the table.

**Margin of Error:** This is a representative sample. However, since the online survey was not a random probability-based sample, a margin of error cannot be calculated. Statements about margins of sampling error or population estimates do not apply to most online panels.

**Note**: Graphs may not always total 100% due to rounding values rather than any error in data. Sums are added before rounding numbers.
